

6TH ANNUAL LAKE SUPERIOR LAWMEN HOCKEY TOURNAMENT



Welcome to the Sixth Annual Lake Superior Lawmen Invitational Hockey Tournament, March 16-17th, 2012. The tournament will feature 24 teams divided into Blue AAA (Upper Division), White AA (Recreational competitive Division) and Red A (Recreational Division) brackets. Each team will be guaranteed three games between Friday and Saturday. The Blue AAA and White AA division will play at Heritage Arena in Duluth, MN and the Red A division will be played at SAHA Arena in Superior, WI.

Entry into the tournament will be on a first come first serve basis. We will make every attempt to place teams in their requested bracket, however brackets can not be guaranteed. Enclosed is the registration forms please fill them out and return with the entry fee no later than February 4, 2011. A \$100 deposit is due as soon as possible to lock your team and division. NO TEAM will be considered locked in their bracket until the deposit is received.
